#### Subject of the Disclosure

Republic seeks to set aside Arbitral Award in favor of Maynilad in Singapore High Court

#### Background/Description of the Disclosure

In the afternoon of 13 February 2018, Maynilad received an email from the Republic of the Philippines's Singapore counsel advising that the Philippine Republic (the "Republic") has filed an application with the High Court of Singapore to set aside the First Partial Award dated 24 July 2017 (the "Setting Aside Application" and the "Arbitral Award", respectively) issued by a unanimous Tribunal in the arbitration between Maynilad and the Republic.

The Arbitral Award upheld the validity of Maynilad's claim against the Undertaking Letter issued by the Republic, through the Department of Finance, and ordered the Republic to compensate Maynilad for its revenue losses, commencing on 11 March 2015 onwards, resulting from the refusal of the Metropolitan Waterworks & Sewerage System to implement Maynilad's relevant tariffs.

While it has yet to be served copies of the summons and the Setting Aside Application, Maynilad is confident that there are no valid and meritorious grounds to challenge or set aside the Arbitral Award, and that the Republic's latest efforts to frustrate and stonewall the enforcement of the Arbitral Award will fail.

Maynilad has already engaged Singapore counsel to ensure that the Republic's baseless application is disposed of expeditiously.
