Item 9. Other Matters

This is to inform the investing public that the Corporation's construction subsidiary, D. M. Consunji, Inc., has signed an agreement with Vertex Tollways Devt. Inc., a wholly owned subsidiary of San Miguel Holdings Corporation for the Engineering, Procurement and Construction (EPC) Contract for the NAIA Expressway Project.

The contract involves about 2.2 km of At Grade Works within the Entertainment City area and about 5 km 4-lane (Phase II Works) elevated viaduct connecting to the existing Skyway (Phase I).

The Phase II Works comprise the design and construction of the viaduct extension from the existing Phase I (near NAIA Terminal 3) to Roxas Boulevard, Diosdado Macapagal Boulevard and NAIA Terminals 1 and 2 over the existing roads of Sales Road, Andrews Avenue, Domestic Airport Road, NAIA Road and Imelda Avenue, and includes on and off ramps, connection ramps and provision of toll plazas.

Pursuant to the requirements of the Securities Regulation Code, the issuer has duly caused this report to be signed on its behalf by the undersigned hereunto duly authorized.
